The OSS license terms are consistent with the license granted under the Contract and may contain additional rights benefiting the Authorized User. The OSS license terms shall take precedence over any license terms which impose greater restrictions on the Authorized User than the applicable OSS license terms. To the extent the license for any Open Source Software requires VMware to make available to the Authorized User the corresponding source code and/or modifications (the "Source Files"), the Authorized User may obtain a copy of the applicable Source Files from VMware's website at www.vmware.com/download/open source.html or by sending a written request, with the requestor's name and address, to: VMware, Inc., 3401 Hillview Avenue, Palo Alto, CA 94304. All requests should clearly specify: Open Source Files Request, Attention: General Counsel. This offer to obtain a copy of the Source Files is valid for three years from the date the Authorized User acquires the Software.

Changes to Product or Service Offerings. Any replacement Product that the Contractor may be required to provide at no additional charge shall have similar features, functionality, and pricing as the discontinued Product. In the event of this occurrence, the Authorized User shall cease use of the discontinued Product and exchange the discontinued Product for the replacement Product.
