Supports with Exceptions	Interfaces are keyboard accessible with some exceptions. A mouse or other pointing device is required to reach, activate, and/or select some elements. Keyboard-only users and JAWS users cannot reach the navigation tabs on the main screen or the navigation list view to the left of the main screen. JAWS users may use the JAWS cursor to focus the navigation list. The navigation tabs provide keyboard accelerator commands.
(b) Applications shall not disrupt or disable activated features of other products that are identified as accessibility features, where those features are developed and documented according to industry standards. Applications also shall not disrupt or disable activated features of any operating system that are identified as accessibility features where the application programming interface for those accessibility features has been documented by the manufacturer of the operating system and is available to the product developer.
